General Information:

SMS AMS Adjuvant is water conditioning agent and nonionic surfactant blend specifically formulated for use with plant control product labels that recommend a nitrogen additive and/or surfactant adjuvant. SMS AMS Adjuvant enhances efficacy of glyphosate and other plant control products by minimizing antagonism from hard water minerals and provides superior leaf surface coverage for maximum absorption.

Directions For Use, Use Rates, Mixing Instructions:

The addition of adjuvants to some plant control products or fertilizer tank mixes may cause discoloration to the foliage or fruit of the desirable crops. Before using SMS AMS Adjuvant, the applicator should have experience with the tank mix combination or should conduct a phytotoxicity test. Always read and follow the label instructions regarding adjuvants found on the plant control product label.

Use Rate: 4 to 5 quarts per 100 gallons of solution.

Maximum use rate provides 4.32 lbs of ammonium sulfate with 0.25% v/v nonionic surfactant.

Mixing: At prescribed use rate, SMS AMS Adjuvant provides 8.5 lbs of ammonium sulfate and 2 quarts of nonionic surfactant. Always follow instructions found on plant control product label regarding mixing order. In the absence of specific mixing instructions, fill the spray tank 1/2 to 3/4 full with desired water volume. Add SMS AMS Adjuvant first to the tank followed by other tank mix partners, followed by remaining water and begin agitation.
