Overview:	No data available. Exposure to solvent vapor concentrations from the component solvents in excess of the stated occupational exposure limits may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures:	Remove sources of ignitions, do not turn lights, or unprotected electrical equipment, on or off. In case of a major spill, or spillage in a confined space, evacuate the area and check that solvent vapor levels are below the Lower Explosive Limit (LEL) before re-entering.
